

MMA Legislative Update

We want to remind everyone that our yearly Motorcycle Day At The Dome is Wednesday 2/19/20 at the state Capitol, 1700 W. Washington. Please mark your calendars and watch for additional information.

Your lobby team is in the process of discussing, drafting, and preparing for the 2020 legislative session. We had a very productive meeting with Alberto Gutier, Director of the Governor's Office of Highway Safety. We talked about a bill we are running in 2020, to extend the Sunset Date on our Motorcycle Safety Fund. The Motorcycle Safety Fund is comprised of the \$1 extra that motorcyclists pay on

their registration. Vehicles pay \$8, except for motorcycles who pay

A Little History:

In 1981, legislation was passed adding an additional \$1 to every motorcycle registration, ARS28-205, currently ARS28-2003. This extra \$1 was placed into a Motorcycle Education Fund. The Director of ADOT was to use those monies to implement a motorcycle testing program and a voluntary motorcycle education program. They were allowed to use public and private agencies to implement the education program.

MVD provided and made available, an abundance of educational motorcycle and awareness materials.

MVD was also tasked to provide motorcycle- testing programs at their sites. By the mid 90's, this task had fallen by the wayside.

In the mid to late 1990's an ad-hoc Motorcycle Advisory Council was brought about by town hall meetings us lobbyists had been attending. We named this council the State Motorcycle Safety Advisory Council (SMSAC), which was made up of representatives from the MRO's, Gold-Wing Riders, Law Enforcement, Motorcycle Businesses and Rider Ed Third Parties.

Lobbyist Report continued

We met and worked with MVD on a regular basis, to recommend various ways for MVD to spend that money in the promotion of Motorcycle Safety and Awareness. We wrote vision statements and guidelines etc. The ad-hoc council continually questioned MVD as to how our approximately \$80,000 a year was and had been being used towards motorcycle safety and awareness. They could not account for one dime of it. Dedicated funds had since been eliminated, and it seemed our monies were lost in the MVD general fund, and being used for who knows what. We also found that there were only a few MVD sites that still did motorcycle training.

In 2001, the motorcycle lobbyists, took action and introduced and passed legislation to re-establish a dedicated Motorcycle Safety Fund (MSF) ARS28-

2010.

In 2002, we met with John Carlson (Governors office) and State Representative Cooley, to draft, introduce and pass legislation to legislatively appropriate our then \$80,000. We amended the language (ARS 28-2010) to move the newly dedicated motorcycle safety fund from 2001, under the realm of the GOHS, and established a 5 person Governor appointed Arizona Motorcycle Safety Advisory Council (AMSAC). Four members of the original ad-hoc council at that time, Bobbi Hartmann (ABATE), Larry Kenyon (DPS motor), Mark Weiss (TEAM AZ),

BIPARTISAN HOUSE BILL WOULD REAUTHORIZE MOTORCYCLIST ADVISORY COUNCIL

"Motorcycles require specific-and in some cases different-requirements of roads, and we need an open dialogue between the motorcycle community, infrastructure experts, and the federal government to discuss these challenges," said U.S. Rep. Mike Gallagher (R-WI) upon sponsoring the bipartisan Motorcycle Advisory Council Reauthorization Act, H.R. 5234.

Rep. Gallagher, alongside Reps. Chris Pappas (D-NH), Troy Balderson (R-OH), and Harley Rouda (D-CA), introduced H.R. 5234 in the U.S. House of Representatives on November 21, 2019 to direct the U.S. Secretary of Transportation to reauthorize the Motorcyclist Advisory Council (MAC) at the U.S. Department of Transportation (DOT) for six years. The MAC, whose authorization under the FAST Act of 2015 expires along with surface transportation programs in FY2021, provides DOT with critical firsthand knowledge on infrastructure and road safety measures and serves as the only official forum for motorcyclists to discuss motorcycle issues with the federal government.

H.R. 5234, if enacted, would require the volunteer body to submit reports to DOT every two years. DOT then would have 60 days to review the council's recommendations and submit a report to Congress.

The measure would also clarify the membership of MAC "to include 12 members, including 5 highway engineering experts from state or local governments, 1 state or local traffic safety engineer who is a motorcyclist, one roadway safety data expert on crash testing and analysis, and 1 representative from each of the following groups: a national association of State transportation officials, a national motorcyclist foundation, a national motorcyclist association, a national motorcycle manufacturing association, and a national safety organization."

CONGRESS CONSIDERS CAPPING ETHANOL CONTENT OF U.S. FUEL SUPPLY U.S. Senator Tom Udall (D-NM) and U.S. Representative Peter Welch (D-VT) introduced companion bills in the U.S. Senate and U.S. House of Representatives on November 14, 2019 "to reform the Renewable Fuel Standard (RFS) by mitigating harmful environmental impacts of the corn ethanol mandate and advancing the next generation of biofuels that actually reduce greenhouse gas emissions," according to a press release issued by Sen. Udall's office.

The GREENER Fuels Act (Growing Renewable Energy through Existing and New Environmentally Responsible Fuels Act) would phase out the corn ethanol mandate and immediately reduce the amount of ethanol in fuel by as much as 1 billion gallons by capping the amount of ethanol that can be blended into conventional gasoline at 9.7 percent.

Such legislation is important to motorcycle riders, in particular, because none of the nation's 22 million motorcycles and ATVs are certified by the EPA to operate on gasoline that contains more than 10% ethanol (E10), and using fuel containing greater than 10% ethanol can damage fuel systems and violate manufacturers' warranties.

MOTORCYCLING GOOD FOR MIND AND

BODY

In a fresh take on a previous UCLA study we reported on earlier this year, visordown.com reports that "A study conducted by the Institute of Neuroscience and Human Behavior (INHB) has concluded that motorcyclists are less stressed and more fulfilled than their four-wheeled counterparts," adding that "The study originally set about trying to find out if bikers were constantly riding in fear of being involved in an accident, but inadvertently proved the opposite! The results center around a certain hormone called cortisol that is released in the brain when we become anxious. Scientists found that bikers would produce 28% less cortisol during testing than drivers on the same course."

The study was conducted by the Semel Institute for Neuroscience and Human Behavior at the University of California, Los Angeles, in a controlled manner, with 50 motorcyclists and 50 car drivers making their way around a closed course for 20-minutes. During this time, the team measured the user's heart rate, cortisol, and adrenaline levels, as well as the user's brain activity, and it's here where the most interesting results came from:

"The results found that when riding, the subjects experienced increased sensory focus and resilience to distraction. Riding also produced an increase in adrenaline levels and heart rate, and a decrease in cortisol levels -- the kind of results you often get after a light exercise session, which also is a stress reducer."

Concluding that motorcycles are better for you physically, as well as mentally, visordown.com claims; "The news regarding the mental wellbeing of motorcyclists goes hand-in-hand with a study that found that riding a motorcycle can burn anywhere between 170-600 calories an hour. As much as some people can burn in an hour at the gym."

NEW YORK POTHOLE MEASURE VETOED Despite passing both chambers of the New York State legislature, including a unanimous 62-0 vote in the state Senate, Governor Andrew Cuomo (D) has vetoed a measure that would have provided strong incentives for more prompt repairs of road defects by expanding the state's liability for damages suffered by road users due to roadway defects, if the state Department of Transportation was notified of the defect and failed to repair it.

Under current law, motorists who suffer damage due to defects on local roads may pursue damages against the locality at any time during the year so long as the municipality had advance notice of the defect, but those who suffer damages due to defects in state roads may pursue these damages against the state only if the incident occurred between May 15 and November 15. A.1235, sponsored by Assemblyman Thomas J. Abinanti (D- Westchester County), and S.5422, sponsored by state Sen. Timothy M. Kennedy (D-Buffalo), would have expanded state liability for potholes on state highways year-round.

Potholes and roadway defects can not only be dangerous to drivers but can prove deadly for motorcyclists, but Gov. Cuomo, who rides and has promoted state tourism aboard his Harley-Davidson, vetoed the legislation on November 25, 2019. Similar measures, endorsed by the Automobile Association of America and the state Trial Lawyers Association, were proposed in 2014, 2015-16 and 2017-18, but never made it out of committee.

ANOTHER STATE INSTITUTES THREE-WHEEL "AUTOCYCLE" RECLASSIFICATION A new "Autocycle" classification will allow consumers to operate a Polaris Slingshot with a

standard driver's license in the state of Wisconsin. Residents of Wisconsin can now operate the three-wheeled Slingshot with a standard driver's license, rather than the previously required motorcycle license or endorsement. The reclassification will take effect immediately.

With a steering wheel and side-by-side seating, state policymakers recognize Slingshot's operator skills mirror those required for a valid state driver's license rather than a motorcycle license and as such, the need for the unique Autocycle classification.

The Slingshot is now classified as an Autocycle in 44 states, including all states bordering Wisconsin. Three states classify the Slingshot as a motorcycle, which requires a motorcycle endorsement or license; Alaska, Massachusetts and New York.

MINNESOTA CITY SEEKS PUBLIC INPUT TO RIDE AN ATV ON CITY STREETS

The Superior, Minnesota city council is considering a referendum on ATV use, and is seeking public input to determine whether or not it should be legal for ATVs and side-by-sides in the city.

According to a report on SuperiorTelegram.com, a council member has "introduced a resolution that would place an advisory referendum on the April 7, 2020 ballot to gauge public sentiment for allowing ATVs and UTVs to use any city street except those deemed exempt because of state and local laws or safety concerns," and may let voters decide if all city streets and alleys could be open to use by all-terrain and utility-task vehicles.

The Superior City Council wouldn't be bound to act based on the outcome of the election, but if the measure is well-supported by the public, the councilman would introduce an ordinance to that effect.

NEW HAMPSHIRE RESISTS EXIT RENUM-BERING

United States highways have been switching to one consistent exit numbering system over the years, and in most states exits now share their number with their closest mile marker, making it simpler for travelers to locate their position and estimate distances between where they are and where they're going.

A few northeastern states have been slow to switch, however, and New Hampshire Governor Chris Sununu (R) believes that holding onto the old sequential exit numbers for the sake of tradition is more important than progress and consistency.

But the renumbering decision isn't entirely up to the individual states, as the federal government has threatened to withhold federal highway funding from states that do not comply with the directive to reassign exit numbers by mileage.

On Twitter, Governor Sununu said, "Exit numbers are a point of pride for some of us in NH -- and we shouldn't let Washington bureaucrats threaten to take that away!"

Numbering exits by mileage is what the rest of the country does, and those few remaining states holding out should probably do the same for consistency for travelers everywhere, though admittedly, this has become less of an issue now that most vehicles, even motorcycles, have GPS capability and can make better decisions based on better information.

TASMANIA BANS THE WEARING OF "OUT-LAW MOTORCYCLE GANG" INSIGNIAS Laws banning the wearing of insignias of five "Outlaw Motorcycle Gangs (OMCG)" has gone



into force in Tasmania (an island state of Australia), and their majority Liberal Government "makes no apologies for being tough on criminals and is delivering on our strong plan to keep Tasmania safer from organised crime."

The legislation "applies to an organisation that displays prohibited insignias that causes the public to feel intimidated and threatened," and their new laws relate to five OMCGs -- Bandidos, Outlaws, Devils Henchmen, Black Uhlans and Rebels, which officials say "sends a clear message that crime gangs are not welcome in Tasmania."

ROYALS POSE ON A MOTORCYCLE FOR THEIR CHRISTMAS CARD

The Duke and Duchess of Cambridge, Kate Middleton and Prince William, along with their three children, Prince George, Prince Louis and Princess Charlotte, casually posed on a motorcycle for their 2019 Christmas card, in stark contrast to last year's more traditional family photo!

The Cambridge Household's Holiday card fea-

tures all five aboard a British-brand motorbike with a sidecar and the salutation; "Wishing you a very Happy Christmas and New Year". Prince William, a longtime motorcycle aficionado, is second in line to the throne behind his father Prince Charles.

and Dick Studdard (GoldWing Riders) were appointed to that initial council. An ex-Tempe police officer rounded out the first 5 appointed members.

The council promoted motorcycle safety and awareness and advised the Governor's Office of Highway Safety on the expenditures of monies in the Motorcycle Safety Fund. The council no longer exists, but your lobby team assures that our monies are going to a good cause.

Our whole goal from the beginning was to use those monies to educate the public through mo-

torcycle awareness AND subsidize motorcycle training!! Thanks in part to AMSAF we have that now. Much of our Motorcycle Safety Fund is used to provide Grants to the Arizona Motorcycle Safety and Awareness Foundation. They in turn provide scholarships to the public to reduce the cost of motorcycle training. This is a very big deal!!!

Our 2020 agenda so far:

- Moving forward the Motorcycle Safety Fund Sunset Date
- Working on language and intro of lane filtering legislation.
- Working with courts so that ticketed riders are

able to attend a motorcycle safety course rather than a driver's class.

- Working with a Senator regarding infrastructure and assuring gas tax is used according to designation.



Meeting of the Minds Report 2019

By Bobbi HartmannThe Motorcycle Riders Foundations chose Bloomington MN as the place to hold their 35th annual Meeting of the Minds. As usual, there were many individual workshops and open sessions to attend. There was the 2020 Legislative Strategy Session, the Shared Goals and Working together SMROs & Motorcycle Clubs, the NHTSA - Protecting our Future from their Past, and Profiling - how it effects all motorcyclists, just to name a few. The wealth of knowledge and camaraderie at these events cannot be found just anywhere.

I always try to take at least one quote away from the initial general session. This year I got that from the MRF Chairman himself, Hardtail. He said, "Don't practice until you get it right, practice until you can't get it wrong!" There was a lot of discussion on assuming positive intent, along with fixing it and making things better. It was pointed out that the MRF itself cannot be healthy if the State Motorcycle Rights Organizations (SMRO's) aren't healthy. We need to leave these conferences smarter and fired up with a take no prisoner's attitude. We need to leave united, which is a big word

We would all do good to adhere to some of the suggestions on working together, that came out of Shared goals & Working together SMROs & Motorcycle Clubs session. We discussed how to bridge the gap and how we had a lot of tools in our toolboxes. How we need to move forward together in order to make a difference. It all evolves around Communications, Respect and Trust. To the State Motorcycle Rights Organizations, lobbying and fighting for our rights is what they do. To others, it may take their life style being threatened for them to stand up, take notice and respond. We need to educate each other on what needs to be done. We need to go from a WE CAN attitude to a WE WILL! Remember, there is no hierarchy when we are doing it together.

There was a discussion on how Profiling affects all motorcyclists. We have found over the years, that a majority of non-club riders do not understand that their stop by law enforcement could be considered profiling. Remember Profiling is defined as follows:

Profiling means law enforcement arbitrarily uses the fact that a person rides a motorcycle or wears motorcycle-related apparel as a factor in deciding to stop and question, take enforcement action against or arrest a person or search the person's vehicle with or without legal basis under the United States Constitution and the Arizona Constitution.

State and Federal Legislative Awards are given out for states that successfully pass legislation. This year the MMA of AZ, ABATE of AZ and the Arizona Confederation of Clubs, received awards for our Anti-Profiling Memorial that is HM2002 that passed our legislature in the 2019 session. The memorial was meant to promote awareness of profiling in Arizona and to set up

collaboration between law enforcement and the motorcyclists, more specifically, the motorcycle lobby. See Picture in this newsletter.

One of my favorite sessions is the MRF's Legislative & Regulatory Priorities. The MRF reviews their High Priority Objectives. These are:

- Continue to lobby for H255 promoting awareness of and condemning motorcycle profiling
- Advocate for targeted changes to Renewable Fuel Standard
- Advocate and monitor for motorcyclists concerning laws and regulations for autonomous vehicles
- Fully engage the EPA/Congress on motorcycle emissions regulations
- Work with stakeholders on federal definition of a motorcycle and ensure crash and fatality statistics are separate from other classes of vehicles
- Work to limit funding of any federal government entity advocating universal helmets
- Continue to promote our theme of crash avoidance versus safer crashes
- Fiercely oppose any federal mandatory helmet, apparel or conspicuity standards
- Pursue legislative language that the consumer has option to opt out of having personal data communicated to interested parties (black boxes)
- Pursue and monitor efforts related to the next highway bill expiring in 2020 and ensure that certain of the following provisions are included:
 - Add issue regarding profiling to the next bill
- Maintain ban of use of Federal funds for motorcycle only checkpoints
- Designate seats for MRO state and federal level to Motorcycle Advisory Council and to advise the FHWA
 - Continue ban on NHTSA and CDC lobbying
- Remove some barriers for states getting monies from Safety Training Fund
- RPM ACT assure motorcyclists ability to do modifications necessary to motorcycles and cars for racing purposes
- Oppose any motorcycling related federal blackmails or federal sanctions

A long time friend and rights advocate Slider Gilmore did a session on "Live to Ride". He discussed some goals that would allow us to live longer healthier lives, and to safely ride for more years. He discussed that how well you live and how you feel about it, turns out to be 80% up to you and 20% genetics. You control how you take care of you! He mentioned how obesity, smoking, abuse of alcohol, stress, sleep, and even healthy teeth, are things that you have a certain amount of control of. Your body needs balance. You need to set goals for yourself and make a concerted effort to stick to them.

Another long time friend and brother of Slider, is Chopper Charlie. He talked to us about measuring richness in friends, brothers and sisters. He spoke of how God will someday take them back and how we need to use them while they are here. He spoke of how true friends give of themselves and their time and money, but most importantly their experience. He suggested that in turn, we should be a true friend to them. We can give love, protection and watch their backs. You can criticize each other in private, but praise each other in public. You need to figure the best approach together. It is important that you respond in a timely manner and be the best that you can be. A quote from Charlie I will remember is "If you want to go fastest, go alone. If you want to further, go with others."

The conference holds a Meet and Greet on Thursday night. This is a very important event, as every state represented gets up and discusses what is going on in their states. As lobbyists, this information can be used to prompt ideas for Arizona and to afford us the opportunity to contact that state to obtain pertinent information for the same. They recently started having each state input their talking points prior to conference, so that a slide show can be presented at the time of the event. Following are just a few of some of the issues being addressed across the country. Many of these states had a long list:

LA – Recently got 5 of their 6 congressmen to sign on to H255, the Anti-Profiling Resolution.
AL – Began use of electronic signage Watch
Out For Motorcycles, Use of emergency lanes on interstate for stopped traffic conditions.
VA – Defeated salvage bill to change the definition to repair a totaled motorcycle, Started steps

tion to repair a totaled motorcycle, Started step for Watch for Motorcycles license plates CO – Left on Red passed

IL – Illinois State Police proposed a policy to withdraw traffic support if 1% involved which ABATE convinced them to drop, Eliminated a banning of vests as 'Gang Attire' from Harvard IL, Statewide campaign to draw attention to Autonomous Vehicles, Working on Capping motorcycle registration fees, increasing motorcycle training fund, having social media campaign regarding grass clippings (big thing for motorcyclists in those states), Amicus brief regarding seizure and forfeiture of membership materials GA – Very successful Cruiser vs Sport bike Events

SCVR – Promote rider education classes for members – reimburse members after they complete rider or Accident Scene Management Class

IA – "Can you see me now" food drive, presented Share the Road to 10,000 students
UT – Passed a lane filtering law which your lobbyists in Arizona are reviewing
MA – An Act to allow interlocking ignition de-

MA – An Act to allow interlocking ignition devices on motorcycles,

NC – Passed motorcycle exception for Mask Act, Expanded Motorcycle Safety Awareness Program (30,000) students

Senate Hearing - Highly Automated Vehicles: Federal Perspectives on the Deployment of Safety Technology

Today the U.S. Senate Committee on Commerce, Science and Transportation held a hearing entitled Highly Automated Vehicles: Federal Perspectives on the Deployment of Safety Technology. This hearing comes on the heels of a National Transportation Safety Board (NTSB) board meeting yesterday regarding the investigation of a March 2018 crash of an Uber Autonomous Vehicle (AV) that resulted in the death of a pedestrian in Tempe, Arizona.

The NTSB released some startling revelations in their investigation of the 2018 deadly crash. Among those that the software did not properly identify the victim as a pedestrian, it did not adequately assess safety risks and the operator of the vehicle was watching a TV show on her phone and was not watching the road. Additionally, the NTSB cited an "inadequate safety culture" at Uber.

The Motorcycle Riders Foundation (MRF) applauds the NTSB and the U.S. Senate for holding public hearings on AV technology and safety concerns. The MRF is committed to fighting for the safety of motorcyclists as this new technology is deployed on our nation's roadways. While we are hopeful that this technology can reduce accidents on our nation's roads, we agree with the statement of Chairman Roger Wicker (R-MS) when he said of AV technology "I think a healthy degree of skepticism is a good thing."

During today's Senate hearing, it was especially important that two U.S. Senators specifically addressed the concerns of motorcyclists during the hearing.

In a question directed to Joel Szabat, Acting Under Secretary of Transportation for Policy, U.S. Department of Transportation Senator John Thune (R-SD) asked, "In developing a regulatory framework for AVs can you speak to how other roadways users such as motorcycles are considered?" The Assistant Secretary responded by saying "Motorcyclists are well incorporated in the development of policy in the department."

Senator Gary Peters (D-MI) echoed Senator Thune's interest in motorcycles when he said, "I am avid motorcyclist. The number one reason for accidents is a car hitting a motorcyclist or a car pulling out in front of a motorcyclist."

Other Senators include Sen. Cantwell (D-WA) raised concerns about the current deployment of AVs without minimum standards from the federal government, "We need some standards." In response, Robert Sumwalt, Chairman of the NTSB agreed by saying that "Whatever is working now is not working as well as it should." We at the MRF agree that minimum standards should be in place as this new technology becomes more and more prevalent on the roads we all share.

Chairman Sumwalt of the NTSB closed the hearing with this statement, "I think that AV technology holds great promise to improve safety, but it has to be done properly." We at the MRF could not agree more.

MRF President Kirk "Hardtail" Willard stated, "As a motorcyclist it offends me when bureaucrats are discussing various inevitable, emerging vehicle and advanced roadway technologies they default to classifying us as vulnerable and in need some sort of protection. I would rather and especially in the specific case of Autonomous Vehicles we be thoroughly considered and fully recognizable and therefore not needing extra protection. As with anything affecting motorcyclists this is another example where the Motorcycle Riders Foundation will demand we remain a significant part of the strategy for roadway users."

HOUSE INTRODUCES MOTORCYCLE ADVISORY COUNCIL REAUTHORIZATION ACT

WASHINGTON, D.C. - Today, Congressmen Mike Gallagher (R-WI) along with Reps. Chris Pappas (D-NH), Harley Rouda (D-CA), and Troy Balderson (R-OH) introduced bipartisan legislation, Motorcycle Advisory Council Reauthorization Act. The bill reauthorizes the Motorcycle Advisory Council (MAC) for six years and ensures national motorcycle organizations regain seats on the council.

The Motorcycle Riders Foundation (MRF), along with our partners ABATE of Wisconsin, ABATE of Ohio, Harley-Davidson, and American Motorcyclist Association, have been hard at work over the past month ensuring the future MAC membership is representative of the riding community. This legislation clarifies the membership of MAC which now will include five highway engineering experts from state or local governments, one state or local traffic safety engineer who is a motorcyclist, one roadway safety data expert on crash testing and analysis, and one representative from each of the following groups: a national association of state transportation officials, a national motorcyclist foundation, a national motorcyclist association, a national motorcycle manufacturing association, and a national safety organization.

"As the feds address the vast roadway infrastructure issues and emerging technologies surrounding vehicles and roads, there isn't a more appropriate time to re-establish the Motorcycle Advisory Council," said Kirk "Hardtail" Willard, President of the Motorcycle Riders Foundation. "It was originally and effectively designed to give motorcyclists a voice with regards to the unique challenges we face on two and three wheels when it comes to roadway design."

The MRF is encouraged that this legislation will ensure that motorcyclists will continue to have an open dialogue with government officials about the unique characteristics and challenges that motorcyclists face when they are not adequately considered or accounted for as infrastructure programs are being discussed and implemented. We want to acknowledge and commend the relationships that our state motorcyclist rights organizations (SMROs), specifically ABATE of Wisconsin and ABATE of Ohio, established with their elected officials through attending events such as our annual lobby day, Bikers Inside the Beltway. This event, along with active engagement with members of Congress in their home districts. helps the MRF identify the champions of motorcycle issues and achieve our goals.

"We are pleased that our elected representatives from the state of Wisconsin continue to lead the charge in advocating on behalf of the motorcyclists in the country," said Steve Panten, Legislative Director for ABATE of Wisconsin, Inc. "I am encouraged that years of building relationships, both in our State and by coming to Washington, D.C., every year, continues to elevate our issues on Capitol Hill. We urge other SMRO's to take the opportunity to do the same."

The MAC, initially authorized in the SAFETEA-LU in 2005, allotted four of the ten members to consist of representatives from the motorcycling community from various state and federal motorcycle associations. In the FAST Act of 2015, Congress re-established the Motorcyclist Advisory Council in the Highway Bill to advise the Federal Highway Administration on "issues of concern to motorcyclists." However, the MRF was disappointed the re-established MAC only included one seat for a representa-

tive of a national motorcycle organization.

The Motorcycle Advisory Council provides the Secretary of the Department of Transportation (DOT), the Administrator of the National Highway Traffic Safety Administration (NHTSA), and the Administrator of the Federal Highway Administration (FHWA) with expert first-hand knowledge of motorcycle issues. "Motorcycle registration is at an all-time high, but this increasing popularity has brought with it increasing risks, such as fatal accidents," said Rep. Gallagher. "Motorcycles require specific – and in some cases different - requirements of roads, and we need an open dialogue between the motorcycle community, infrastructure experts, and the federal government to discuss these challenges." The MAC serves as the only official forum for the motorcycle community to have an open dialogue with the federal government to discuss concerns with infrastructure design, issues with intelligent transportation systems, and other areas of safety affecting motorcycles on the road.

"With the number of motorcycles currently on the road, it is critical that the road designers and transportation engineers understand the way that motorcycles and motorcyclists interact with the roadways as well as other vehicles using those same roads," said Ed Schetter, Executive Director for ABATE of Ohio, Inc. "Motorcyclists need to be present to help recognize those needs and ensure that motorcycles maintain their place on the road and can be safely operated into a future where technology is creating more and more challenges."

More heads roll over Harley smuggling in Indonesia

JAKARTA: The flag carrier Garuda Indonesia is suspending directors linked to the alleged smuggling of a Harley Davidson motorcycle by its chief executive, the airline's chief commissioner said on Saturday.

State-Owned Enterprises Minister Erick Thohir earlier announced his intention to fire the airline's CEO, Ari Askhara, for allegedly trying to evade tax by bringing into the country a Harley Davidson motorbike onboard a new Airbus plane being delivered from France.

Askhara has been suspended pending a share-holders' meeting to determine his fate.

Thohir said the smuggling also involved at least one other Garuda employee based in Europe who helped transfer the payment and assisted in the delivery of the motorbike. He said the investigation would continue to ascertain whether more employees were involved.

Sahala Lumban Gaol, chief commissioner of Garuda, said on Saturday that members of the board of directors who were "indicated to have been involved directly or indirectly" in the incident had been suspended.

He declined to name the suspended directors or say how many were affected.

Askhara has not responded publicly to the accu-

sations of smuggling. Reuters made repeated unsuccessful attempts to contact him for comment.

Chief financial officer Fuad Rizal has been named acting CEO until a shareholders' meeting to formally name a new chief is held, Garuda said in a statement on Friday.

Transportation Minister Budi Karya Sumadi on Friday Garuda would be fined for not including the motorbike in the cargo list. The motorbike had been torn down and the parts packed in separate boxes.

Two expensive undeclared Brompton bicycles were also found onboard the plane.

Accident Rate Continues To Drop On US Roads

Despite more vehicles on the road than ever before, the number of accidents in the US continues to drop.

NHTSA report cover

America's roads growing safer, even as states push speed limits as high as 85 MPH. The US Department of Transportation last month counted 6.7 million accidents reported by police in 2018 -- a 2.4 percent drop even as the number of vehicles on the road surpassed the all-time record.

"New vehicles are safer than older ones and when crashes occur, more new vehicles are equipped with advanced technologies that prevent or reduce the severity of crashes," National Highway Traffic Safety Administration (NHTSA) Acting Administrator James Owens explained in a statement.

In 2018, there were 1.13 fatalities for every 100 million vehicle miles traveled, compared to 1.17 in 2017 -- a 3.4 percent reduction. Preliminary 2019 numbers are even better, with a fatality rate of 1.06 posted for the first half of the year. Fatality figures are from the agency's fatality database, which contains the most reliable statistics. Numbers for injury and property damage accidents come from NHTSA's recently revamped crash sampling database that makes nationwide estimates based on a representative sampling of police reports. The system estimated 1.9 million injury crashes and 4.8 million property damage collisions, which combined with 33,654 fatalities for a total of 6.7 million incidents. Accidents that only result in property damage accounted for 71 percent of accidents.

"There was a statistically significant increase in property damage only crashes from 2017 to 2018," NHTSA's research note explained. "This increase is primarily related to changes in property damage reporting criteria at some data collection sites."

Several states stopped allowing police to report the estimated damage from a crash as "unknown," a change that results in more incidents being recorded as a reportable crash.

Figures from the NHTSA database also show that in 2018, there were 492 fatal rear end collisions at intersections in 2018. Supporters of red light cameras often downplay the seriousness of rear end collisions as "minor fender benders" since the use of automated enforcement is known to increase the number of rear end accidents (view studies). About 65,000 accidents nationwide involved buses.

A soldier tried to buy a motorcycle in Anchorage. His lawyer says he was targeted by a 'yo-yo scam'

This past August, Army Specialist Austin Deehan bought a 2014 Harley Davidson from a dealership in south Anchorage.

"It felt great. It was a beautiful bike," Deehan said.

He made a \$2,599 down payment, and financed the remaining \$10,630 with at a decent interest rate.

But 19 days later, when he called the bank about setting up monthly payments, they told him the loan had never been approved. That, Deehan said, is when he knew something was wrong.

On Tuesday, Deehan filed a civil case in state Superior Court alleging misconduct by a local car dealership over a financial arrangement critics call a "yo-yo scam." Though hardly a block-buster piece of litigation, it highlights something federal regulators, lawyers, and financial services observers say is commonplace: nationally, military service members are some of the most commonly targeted demographics for credit and financing scams.

When Deehan spoke to the bank he believed was financing his loan, they told him the denial was because his application was missing paperwork.

He went back to the dealership, Chevrolet of South Anchorage, where he was told that since the financing deal didn't go through he would need to take out a more expensive loan, he said.

"They gave me two options: Either I could refinance the bike with a higher interest rate, or I could return the motorcycle and lose my whole down payment," Deehan said.

That's when Deehan sought out legal assistance at Joint Base Elmendorf-Richardson, where he is stationed. His complaint was filed by the Northern Justice Initiative, a private firm that handles civil rights cases. According to Nick Feronti, one of the lawyers on the case, the dealership wrongly told Deehan that if he returned the

motorcycle the company would keep the full balance of the down payment, plus charge him hefty mileage and daily-use fees that are generally prohibited under Alaska law.

"The dealership actually tried to use an illegal contract to coerce him," Feronti said. "The way the law is supposed to work is: they tell you you have financing, and then if you don't get approved, well you can bring the vehicle back and get your down payment back."

He believes the actions alleged are a textbook example of a "yo-yo scam."

"These dealerships will count on consumers to buy a car, buy a motorcycle," Feronti said. "You go home and show it off to your family and you're feeling really happy about it. And then later on you learn that for whatever reason you actually have to accept much worse financing."

Reached by phone, Chevrolet of South Anchorage General Manager David Raff wouldn't agree to a recorded interview. He had not seen the complaint, and said he was only able to speak in general terms. But he defended the business's practices, saying there are no shady financing deals or use-fees, in part because in a state as small as Alaska those kinds of things would damage the company's reputation. Asked about an allegation in the complaint that Raff called Deehan in September and "threatened to make his 'life a living hell' unless he immediately returned the motorcycle," Raff said it wouldn't be appropriate to comment on a specific legal case. He added that if there were those kinds of complaints against the business, they should be assessed against the company's otherwise strong

Online, that record does not look great.

In the last three years, 10 complaints have been filed with the Better Business Bureau against Chevrolet of South Anchorage, ranging from accusation of shoddy mechanical work to what sound like predatory financing arrangements. With 29 reviews, the business has two stars on Yelp, many of them making similar complaints.

The dealership is part of Lithia Motors, one of the country's largest car retailers. Over the years, Lithia has had multiple class action lawsuits filed against it over business practices. Kara Southard, corporate counsel for Lithia Motors, said she had received the complaint in the Anchorage case, but was not able to comment on it.

State officials in Alaska recognize that servicemembers are frequent targets of scams.

"There's national data out there that says that a lot of scams are perpetrated against members of the military, that's a really common thing," said John Haley, the assistant district attorney in charge of the Department of Law's Fraud Division.

Those complaints are often taken up by U.S. Government agencies like the Federal Trade Commission, Consumer Financial Protection Bureau, and Department of Justice, all of which have special efforts to specifically combat fraud against active duty military and veterans. According to Haley, state offices like his don't get a large volume of calls from active-duty military, but they understand the reasons they are often targeted.

"Scammers want go after members of the military because they have very steady paychecks that are guaranteed by the government," Haley said. "And because so many of the members of the military are relatively young people who are getting money and getting paychecks for the first time."

Eventually, Specialist Deehan got his down payment back. He's suing the car dealership for damages of up to \$10,000 plus legal costs. And he wants the dealership to agree to halt the lending practices he believes are wrong.

"There's guys out there that are fresh out of high school that I work with, and if they went through the same situation that I went through they probably would have signed another contract" Deehan said. "That's just not ok."

Deehan no longer has the Harley Davidson, but hopes to get another after he leaves the Army next year.
















